# **EEM Dynamic BuyWrite**

The Validus EEM Dynamic BuyWrite Strategy is a systematic options overlay that enhances a long position in international developed markets (via EEM) by selling short-dated call options on a recurring, rules-based schedule.

The strategy writes options across multiple monthly roll dates to generate consistent income while helping attenuate the downside risk. This disciplined approach seeks to reduce portfolio volatility, improve risk-adjusted returns, and deliver a smoother return profile compared to a long-only allocation to EEM.
